


eCAP PARTNER / D-Rating 2021 Barometer:

Funds invested in French fintechs and insurtechs tripled in 2021; Insurtechs were particularly well supported


In 2021¹, funds raised by French fintechs and insurtechs reached record levels since 2018, and by far: the sector tripled its level of fundraising: €1.45bn vs 2020 (€532m) or 2019 (€469m).


"Adding Lydia, entering these last days in the unicorn's club, it confirms the strong attractiveness of French Fintechs' ecosystem", notes Numa Bourragué, eCAP PARTNER's founder & managing partner. Assurtechs have been, by far, the most strongly supported by investors, with nearly €550M raised in 2021 vs €328M to neo banks and b2c payment services.

"Specialized business service providers - from ETP supplying to credit offering - were the No. 2 target for investors in 2021, adds Philippe Bailly, D-Rating's president. The many partnerships they are forging with SME bankers are helping the latter to broaden their value proposition, as D-Rating noted in its first SME banking rating campaign".
